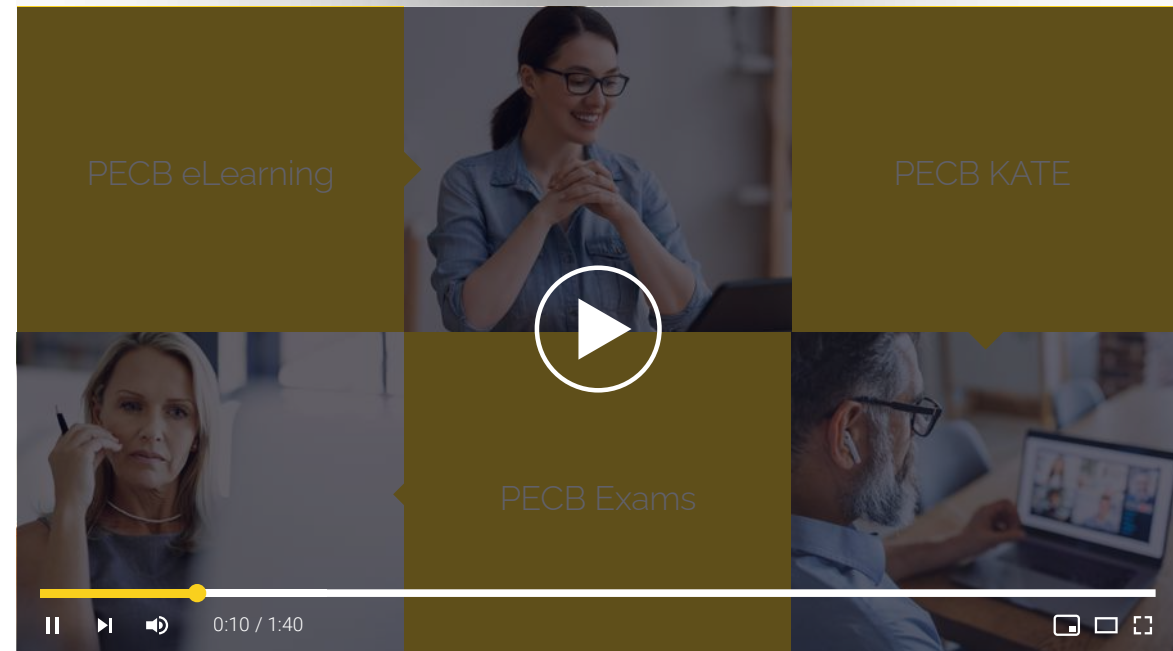
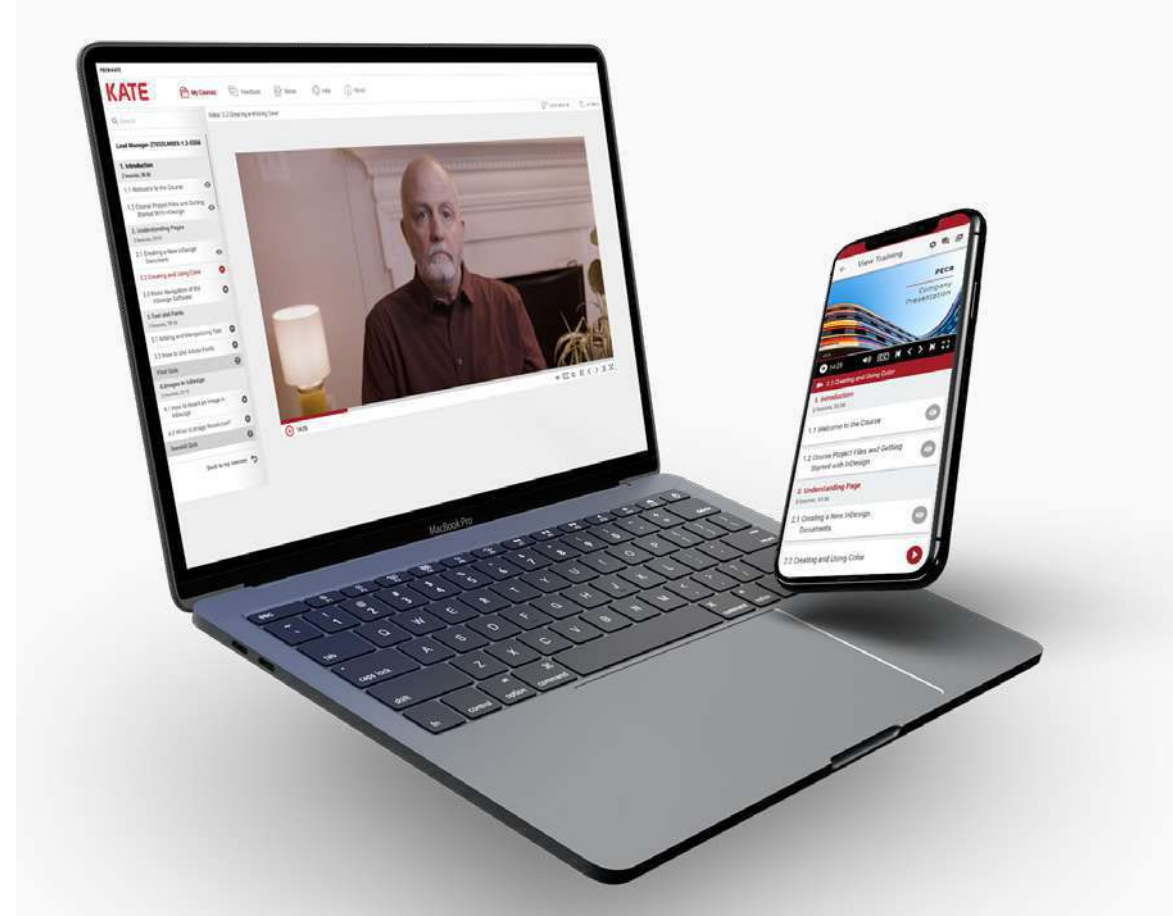
# How does the ISO 9001 Lead Implementer eLearning experience look like?

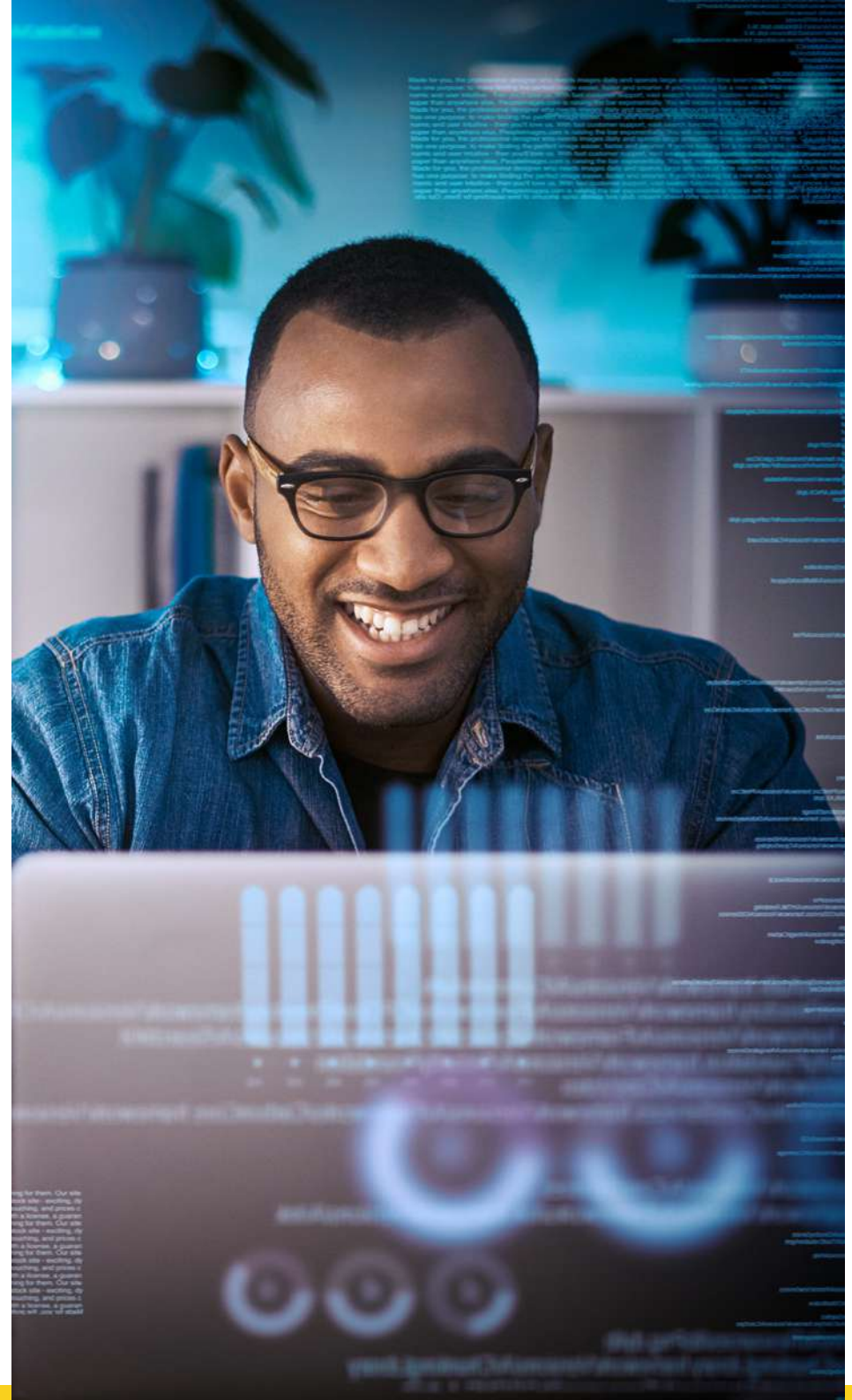
