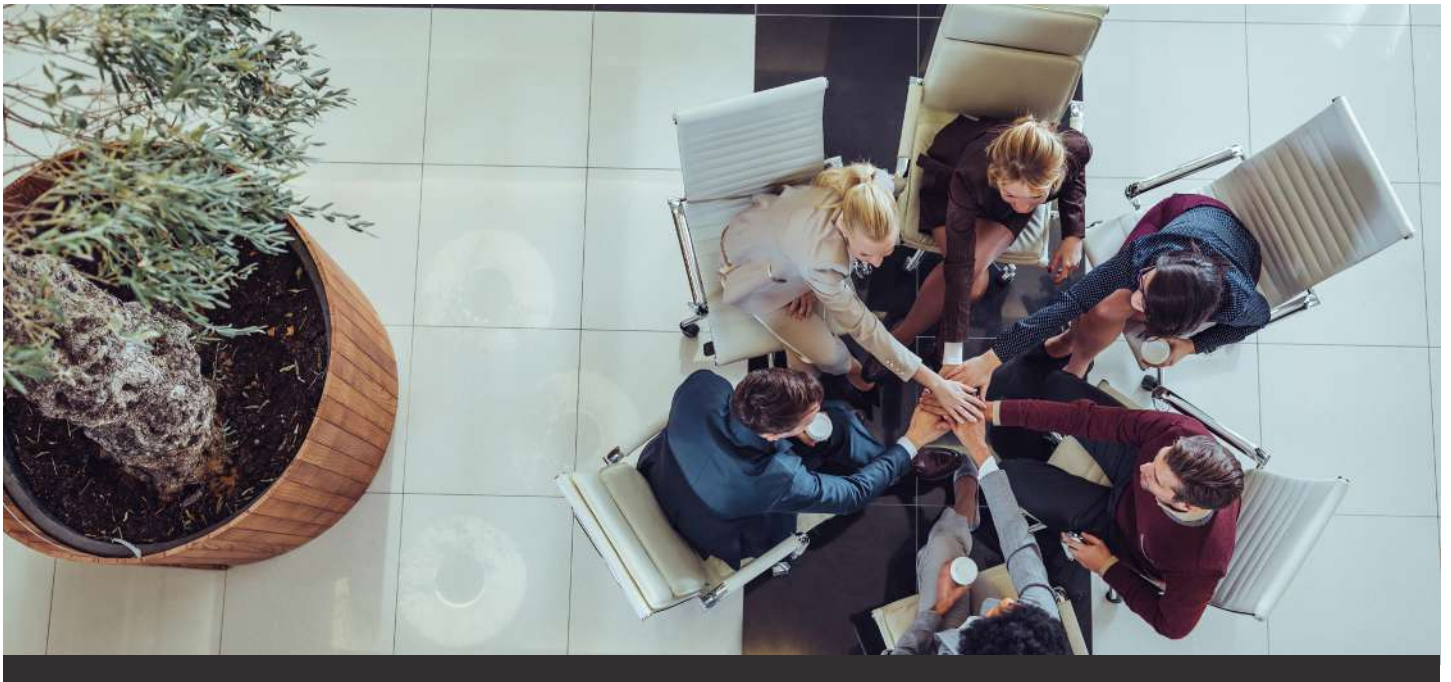
## Examination
